**ACTION ALERT #1:** Write to support Denmark's SIAD right to assemble against radical Islamists

Denmark has several organizations working to stop Islamofascism. One of the newest and most active is the [SIAD](#), which roughly translates in English to "Stop the Islamification of Denmark." [SIAD is made up of ordinary Danes](#) with a peaceful and democratic message to all. Yet the Danish Minister for Justice, Lene Espersen, is denying them the right to publicly and peacefully go out and demonstrate, for fear that they will "create a public disorder" by being attacked by Islamist and leftwing groups. Espersen has declared "emergency laws" against SIAD, since courts have upheld their right to protest. [On January 13](#), a peaceful SIAD meeting (not even a protest) was broken up by Islamist and leftist gangs and three SIAD members were hurt. They are asking for support. Write to Lene Espersen at the Danish Ministry for Justice at [jm@jm.dk](mailto:jm@jm.dk), and ask for SIAD to be given their constitutional right to demonstrate.

**ACTION ALERT #2:** Write to the UK's Channel 4 and thank them for airing the shattering documentary, "Dispatches: Undercover Mosque".

Channel 4 aired this superb documentary in spite of intense pressure from the entrenched Islamist organizations within Britain. The program takes a hidden camera inside Britain's 'moderate' mosques to see what types of messages are being given. The answer: a vitriolic message of hate and intolerance against Western values and freedoms. The documentary features a surprisingly clear portrayal of just how deeply entangled supposedly moderate Muslim imams are with radical Islamic ideologies. **ACTION ALERT #3:** Oppose Legislation that will Stop Criminal and Terrorist Profiling

Check your state legislature for bills that will stop efforts to profile potential criminals, including terrorists. We oppose any efforts to limit or stop profiling. Citizens and nations have a right to profile potential threats, and to protect themselves through observation and intelligence gathering. We are organizing a tracking system for state and federal legislation of concern to our members. You can help with this first effort on tracking for any anti-profiling legislation. Below is the link to a [Rhode Island bill](#) that is dangerously similar to the [CAIR-promoted ERPA federal legislation](#). It would prevent police from inquiring about someone's immigration status or demanding documentation -- except when required by federal law or in other select circumstances.

Please check if your own state legislatures have any similar bills being proposed this year. We need to find out if this is a state-by-state attack on our ability to protect ourselves, as an effort to achieve the federal ERPA bill's intent. #### ACTION ALERT #4: Help Nazanin and other Iranians Unjustly Condemned to Death

In last week's newsletter, we asked for your help in signing a petition to free 19-year old Iranian Nazanin Mahabad Fatehi, who was previously sentenced to death by hanging for killing a man who ambushed and tried to rape her. View a powerful documentary about Nazanin and the Iranian injustice system: [A Tale of Two Nazanins](#). Nazanin's re-trial ended on January 10, and [she will be exonerated](#) from the charge of murder, but will still have to pay blood money to the family of the deceased before she can be set free from prison. Nazanin's lawyers intend to appeal the payment of blood money, but since this appeal may take several months, they have also requested bail so that Nazanin may be released from prison immediately. The court has set bail at 400,000,000 rials (over US\$40,000). Because Nazanin's family is very poor and unable to make payment of the bail or blood money, immediate financial assistance is required to secure Nazanin's release from prison. [They ask for your help](#).

At least 23 teenagers are on death row in Iran; their ages at the time of their offence ranged from 15 to 17. You can [demand an end to these unjust executions](#) in Iran.

#### CENTER FOR VIGILANT FREEDOM WEBSITE IN DEVELOPMENT

The public face of the 910 Group is being developed, as a content rich website for the non-profit organization the Center for Vigilant Freedom. We hope to have this launched in early February. In addition to the usual information, the new CVF website will include an aggregation of content, contacts and calendars from other anti-Islamofascist organizations, extensive research materials and tools for understanding the methods of radical Islam and countering them, links for contacting Congress and the media, legislative updates, and by late February, the first reports developed by our investigative teams. #### PORTAL TRAINING:

The Portal is built using an easy, user-friendly software application called Moodle, originally designed for extensive collaboration by students and teachers in distance learning. In fact, universities around the world are using Moodle in 160 countries, 75 languages, over 1.3 million registered teachers and over 12 million registered students. We are one of the first groups that we know about, to adapt it to project work: teachers become "project managers" and students become "activists" in the way we are using the application.

Over forty 910 Group members are now either working in projects in the Portal or in process. We hope to provide opportunities for hundreds more members to work on projects in the Portal as well. Beach Girl, the 910 Group Training coordinator, has completed the initial training section for the 910 Portal. It is intended for everyone who will be working

on 910 projects. The idea is for participants to learn, practice, and have fun in an environment where they can experiment with the various Moodle features before they move into their actual project areas. Training has been kept simple, but covers all the major areas of the Portal, including how to find your project, setup your profile, contribute information to the project, and how to communicate with other group members. After you get your username and password and login, just scroll down to "Portal Orientation and Training."

## CITIZEN INFORMATION GATHERING OPERATIONS

CIGO is a beehive of activity, with multiple teams focusing on research, special projects, and the formation of an information network fed constantly from monitors and reporters across the globe. If you have already read through the Forum, you'll know that in 910, CIGO is the acronym for Citizen Information Gathering Operations. The best way to think about it is that CIGO is you, me, and your neighbor, "doing the work."

What does a CIGO volunteer do? We monitor town council meetings, keep an eye out for proposed ordinances, zoning changes, the lease and sale of city or federal land. Identify CAIR activities and monitor candidates that give us cause for concern. We participate in school board meetings, inspect curriculum. We start taking back our democratic system of government that our enemies employ so artfully against us. And that is just the tip of the iceberg.

This week we backed up the moving van and piled it with boxes from the Forum. You can compare it to moving from a cramped room to a well-equipped suite of offices.

If you have proposed some good ideas in the Forum, rest assured they have not fallen between the cracks. All of the ideas delivered to CIGO since its inception has been ferreted out and carried over to the Portal where fully equipped workrooms are being prepared to accommodate the volunteers who will pound them out into reality.

We are currently putting over 15 CIGO volunteers through moodle training with several short term assignments immediately available.

1. CIGO needs volunteers to identify and provide links for all bloggers in their immediate region that take a stand against Islam. Please reply with links and locations.
2. CIGO is seeking to collect all incidents of CAIR/ACLU/ADC/MAS/MSA etc. intimidation that has occurred in your city or region. This can also include incidents that have reached litigation, past and present.
3. CIGO is seeking to collect names of reporters and columnists in your city or region who have written critically of CAIR or have taken a stand against Islamic incursions. Please provide links to the publications they write for and any articles that pertain.
4. CIGO is seeking to collect news about any mosques or Islamic schools being built or proposed in your city or region. Please provide links to all relevant articles or notices.

We are also looking for those with experience in project management to take on a leadership role in the ongoing development of CIGO.
