FOX NEWS NOTICE: On Sunday night, February 18, on Fox's "Hannity's America" show, airing at 9:00pm ET, an exclusive undercover video shot by the Investigative Project on Terrorism over a series of years of a radical Islamic cleric, Sheik Abdul Alim Musa, will be broadcast on the Fox News Channel. The Imam, who presides over two mosques and a popular Islamic organization, has actually been invited to White House Ifthar dinners.

The Investigative Project on Terrorism (IPT) shot this undercover video of Musa during a period of 7 years. About 5 minutes of incendiary IPT video is expected to be broadcast at around 9:30pm ET during which time Hannity will be confronting Musa live about his violent exhortations. Later this year, the Investigative Project on Terrorism will be releasing the full out-takes of the extremist speeches and rallies led by Musa calling for suicide bombings and his violent anti-Semitic and anti-American speeches. What is most shocking is the degree to which Musa has achieved "mainstream" status in the Muslim community.

ACTION ALERT #2: Phone Fox News to Pursue Investigation into SLC shooting

A couple of days ago five people were murdered in Salt Lake City, Utah. The murderer was an 18 year old Bosnian Muslim immigrant, Sulejman Talovic. According to the Salt Lake Herald Tribune, he regularly attended the Al-Noor mosque. While, detectives did not take any computers from his house to investigate possible links to terrorism, in a matter of hours the FBI hours released statements indicating there is no link to terrorism. Fox news contacted writer Dave Gaubatz to speak about the FBI immediately assuming there was no terror link. Now Fox is receiving political pressure to not pursue this. Contact Fox News at 801-973-5423 and request they follow through with Dave Gaubatz's interview and do their own investigation of possible terrorist links. This is a tragedy for all involved, and another example of a Muslim going on shooting sprees that is then dismissed by law enforcement as not being related in any way to extremism or terrorism, based on minimal investigation.

ACTION ALERT #3: Email support for Denmark's SIAD for their February 24 Demonstration

This is an update to the ongoing struggle of the peaceful citizens Danish citizen's group SIAD (translated as Society against Islamification of Denmark) to conduct a public protest in Copenhagen. Please write to Lene Espersen at the Danish Ministry for Justice at jm@jm.dk, and ask for SIAD to be given their constitutional right to demonstrate February 24. SIAD has met another obstacle in their efforts to hold a peaceful demonstration. Last month, we asked 910 Group members to send emails, and your efforts with those of Danish citizens, succeeded in convincing the Minister for Justice, Lene Espersen, to allow SIAD to hold a peaceful protest, a Danish constitutional right. However, she also allowed local law enforcement to deny the right on an ad hoc basis. SIAD then applied for a license to demonstrate in Nørrebro in Copenhagen on February 24, an area rapidly becoming a "no-go" zone for law enforcement. The chief constable for Copenhagen, Hanne Bech Hansen, then ruled that the demonstration cannot happen, even though SIAD is only proposing a peaceful demonstration to defend the constitutional rights of Danish citizens.

ACTION ALERT #10: Help the Sunlight Foundation Citizen Research Project

The Sunlight Foundation Wants You To Research Congressional Web Sites!

The Sunlight Foundation is launching a new citizen journalism project. This distributed research project asks you to dig through the official, taxpayer-funded Web site of a member of Congress, and help determine those that act as genuine tools for transparency. They're asking questions in three broad areas: does the member of Congress provide access to basic information on what they do in Congress (the bills they sponsor, the committees they serve on); do they provide information from or access to any of the legally-required disclosures they have to file (on personal finances or junkets they take); and do they provide any additional information that furthers transparency (their daily schedule, lists of earmarks they've asked for or gotten)?

They're asking you to help determine whether a member's web site serves the interests of the citizens who pay for it. The findings will be used to highlight the best practices and to develop a set of transparency standards for sites of members to meet.

UPDATE #1: Get the word out: Numbers Don't Lie: CAIR and MAS have few members

These two articles are good news - we strongly urge reading both. The key quote from the Front Page Magazine article, on CAIR (Council on American-Islamic Relations) and MAS (Muslim American Society):

"An inspection of CAIR's most recent publicly available IRS Form 990 (2004) shows for that year they received \$119,029 in membership dues for that year (line 3). But at \$25 per membership (the current rate is \$35), that would mean that in 2004, CAIR only had 4,761 dues-paying members – less than 5,000 members out of 8 million Muslims in America. This would mean that CAIR only represents 1 out of every 1,680 Muslims. Even if a lower 6 million Muslim population figure were assumed, CAIR could still only claim representation for 1 out of every 1,260 Muslims for that year.

* MAS is in even less representative than CAIR. In 2004, MAS received \$87,299 in membership dues -- a dramatic decrease in membership from 2003 (\$366,613 in members dues received) and 2002 (\$378,993 received). Membership has declined so rapidly for MAS that they have stopped offering memberships on their website altogether, though MAS has not publicly acknowledged, let alone explained, their stunning membership decline since 9/11."
