ACTION ALERT #1: Support School Teacher Under Attack From CAIR

A School system in North Carolina is under attack from the Council on American Islamic Relations (CAIR) after a teacher invited a Kamil International Ministries Organization representative to present a program on Islam and Christianity to students. The presentation involved literature with side-by-side comparisons of the Koran and Bible, and statements critical of Islam. CAIR is demanding an apology.

The Wake County School system and administration of Enloe High School must be reminded that students must make their own determinations and should be able to hear information about Islam that isn't only "CAIR-approved". It is un-scholarly and un-American to provide just one perspective— especially when our youth are constantly seeing news that leads them to question the relationship of Islam and violence.
