**ACTION ALERT #2 – SIGN THE PETITION FOR FREE SPEECH OF EGYPTIAN BLOGGER**

Egyptian law school student and blogger Kareem Amer, 22, has been in solitary confinement in Alexandria, Egypt, since November 6, 2006, after posting to his website statements critical of Islam and calling for equal rights for women and protection of free speech. Denied bail, he faces a 9-year prison sentence if convicted of the charges held against him, which include “incitement to hate Islam.” Students and human rights activists held a rally outside the New York City Egyptian consulate January 31, 2007, demanding his release. **ACTION ALERT #3 – WRITE TO ABC AND DEFEND GLENN BECK FROM CAIR**

Write ABC News requesting they keep Glenn Beck on as a “Good Morning America” commentator. His new role as host is under attack from The Arab American Institute (AAI), American-Arab Anti-Discrimination Committee (ADC), Muslim Public Affairs Council (MPAC), and the Council on American-Islamic Relations (CAIR). They allege he is biased against Muslims because he asked Muslim Rep. **ACTION ALERT #4 – MONITOR LOCAL EFFORTS TO STOP IMMIGRATION CHECKS**

Watch in your community for news that CAIR may be trawling for ‘victims’. CAIR, and other groups such as the American-Arab Anti-Discrimination Committee (ADC) are creating cases about delays in immigration processes to build support for submitting bills to Congress – including the End to Racial Profiling Act (see 910 Feature article on ERPA, below). Usually, after an immigrant has taken the citizenship exam, they are due a decision within 120 days -- IF there are no irregularities. If you find examples of CAIR recruiting stories in your local press, contact [Terresa@noisyroom.net](mailto:Terresa@noisyroom.net), the 910 Group Legislative Services coordinator. CAIR systematically looks for the slightest of “incitements” so they can claim discrimination or hate crimes. This week they are looking for citizenship delays in New Jersey; next week it could be your neighborhood. Keep on watch and let us know.

**ACTION ALERT #6 – SUPPORT A SMALL CANADIAN TOWN TRYING TO INTEGRATE MUSLIMS INTO MAINSTREAM CULTURE**

Support the Quebec village of Herouxville and the Ministries of Immigration of Canada and Quebec to educate Muslim immigrants about how to live in the modern world. Apparently, some don’t realize it isn’t legal to stone women and the municipality now has specifically banned the stoning of women, face veils, female genital mutilation, or throwing acid at unveiled women’s faces. André Drouin, a municipal counselor in Hérrouxville,

says it was important to inform new immigrants of cultural norms: "The Muslims who wanted to impose Sharia, had they known that we do not stone women here, maybe they would not have come."

**UPDATE #1 – "910 GROUP VIDEO PRODUCTIONS" EXCLUSIVE VIDEO OF THE DANIEL PIPES VS. LONDON MAYOR LIVINGSTONE DEBATE: A CLASH OF CIVILIZATIONS**

On January 20, 2007, Daniel Pipes (<http://www.meforum.org/>) debated London Mayor, "Red Ken" Livingstone, in an event attended by over 150 media and an audience of thousands – BUT no video or audio was posted, amounting to a virtual Mainstream Media blackout. An enterprising 910 Group founding member, Flyboy1950, videotaped the entire debate, preserving a resounding victory by Pipes. UK members Willy and Gaia immediately transferred and edited the video and uploaded it here: [YouTube](#). ## UPDATE #2 – THE THREE EX-TERRORIST EVENT AT UNIVERSITY OF MICHIGAN

Update taken from Keith Davies, Director of the [Walid Shoebat Foundation](#):

... a capacity crowd of 1,100, including about two hundred terror sympathizers attended, along with local media and Fox News. After the event they recorded 5 hours of tape for two separate TV documentaries, the first to air is this Saturday on Fox, February 3 at 9:00 pm ET and Sunday at 12:00 am ET. It will feature Walid Shoebat. During the event about 200 terrorist sympathizers walked out about halfway through. All speakers were heckled, but the majority of the crowd was on Shoebat's side or neutral and all speakers were able to complete their positions. Shoebat Foundation is confident that this work is making a difference and that slowly but surely they are getting the message out and waking up America. This was Walid's most successful event yet. Next Tuesday, February 6th, Walid speaks at University of California, Davis, and on Wednesday February 7th at UC Santa Barbara Campus.

### FEATURE ARTICLE: STOP THE “END RACIAL PROFILING ACT” (ERPA)

You'll hear a lot about the End Racial Profiling Act – ERPA - in the next months: just what is ERPA, and why do we think it will seriously threaten our ability to protect the U.S. and our Allies? ERPA would bar any federal, state or local law enforcement agency from "relying, to any degree, on race, ethnicity, national origin, or religion in selecting which individuals to subject to routine or spontaneous investigatory activities." That would include questioning, searches and seizures. ERPA failed to become law when it was introduced in 2001 and 2004, but this session may be different. Speaker of the House Nancy Pelosi (D-CA), Rep. John Conyers Jr. (D-MI), Senator Russ Feingold (D-WI) and newly elected “CAIR's Congressman” Rep. Keith Ellison (D-MN) will reintroduce ERPA in this Congress, and all consider it a high priority. It's a disastrous piece of legislation: the epitome of Dhimmitude.

--- ERPA defines “Racial Profiling” as any human characteristics, and would prohibit a “... law enforcement agent relying, to any degree, on race, ethnicity, religion, or national origin in selecting which individuals to subject to routine or spontaneous investigatory activities, or in deciding upon the scope and substance of law enforcement activity following the initial investigatory procedure.”

--- ERPA Prevents Law Enforcement: Those “routine or spontaneous activities” include “interviews; traffic stops; pedestrian stops; frisks and other types of body searches; consensual or nonconsensual searches of the persons or possessions (including vehicles) of motorists or pedestrians; inspections and interviews of entrants into the United States that are more extensive than those customarily carried out; immigration related workplace investigations; and such other types of law enforcement encounters compiled by the FBI and the Justice Department's Bureau of Justice Statistics” [therefore all possible criminal or intelligence or homeland security situations].

--- ERPA Compromises National Security:: ERPA would expand the 2003 Judicial guidance against racial profiling because that guidance “contains an overbroad exception for immigration and national security matters.”

--- ERPA Guarantees Full Employment for Trial Lawyers: It encourages lawsuits in the event of any profiling against any governmental unit that employed any law enforcement agent, any agent of that unit, or any person with supervisory authority over that agent.

--- ERPA Requires No Actual Proof other than Guilt by “disparate impact”: CAIR and the ACLU can just assert a “disparate impact” to justify lawsuits, rather than needing any “proof”: “Proof that the routine or spontaneous investigatory activities of law enforcement agents in a jurisdiction have had a disparate impact on racial, ethnic, or religious minorities shall constitute prima facie evidence of a violation of this title.”

--- ERPA Guarantees Extortionate Fees to Trial lawyers and Islamist “Experts”: U.S. taxpayers get to pay trial lawyers' fees, and expert fees to CAIR and other “disparate impact” experts: “In any action or proceeding to enforce this title against any governmental unit, the court may allow a prevailing plaintiff, other than the United

States, reasonable attorney's fees as part of the costs, and may include expert fees as part of the attorney's fee.”

--- ERPA Paralyzes Homeland Security with Reporting and Paperwork: Police will stay busy collecting “data on routine investigatory activities sufficient to determine if law enforcement agents are engaged in racial profiling,” plus complying with “independent [CAIR, ADC, INSA, MAS] procedures for receiving, investigating, and responding meaningfully to complaints alleging racial profiling by law enforcement agents,” and the all important CAIR-bullying provision, “procedures to discipline law enforcement agents who engage in racial profiling.”

--- ERPA Puts CAIR, ADC and ACLU in charge of Law Enforcement Grants Programs: Localities can only apply for a wide range of unrelated DOJ federal grants if they're certified as non-profilers (including Local Law Enforcement Block Grants), and guess who can block certification: “private parties [CAIR, ADC, ISNA, MAS] to present evidence to the Attorney General that a grantee is not in compliance.”

--- ERPA Guarantees Lucrative Grants to Extremist Islamist Trainers and Enforcers: DOJ provides grants to public and private organizations to provide training, data collection and systems to capture any possible profiling, including “in-car video systems.”

ERPA will aide Jihadists and terrorists, while simultaneously tying the hands of Homeland Security and other agencies trying to protect us from terrorist attacks. It would give Islamofascism a giant boost towards undermining our government and gaining a strong foothold here in the United States. Intelligence assessments would become almost impossible and would be weakened to the point of uselessness.

“...Such folly would keep our courts busy entertaining frivolous lawsuits driven by cherry-picked data and our law enforcement agencies more concerned with sticking to quota than solving and preventing crimes. Daniel Horan of the LAPD, who spent 6 years at the Los Angeles airport on profiling-related issues agrees: "A law that would compel security professionals to focus on keeping their statistics within certain norms rather than on their mission keeping airline travel safe would have a devastating effect on our ability to ensure airline safety. Moreover, such a law would ultimately provide exclusionary cause for captured terrorists, as well as yet another "blame the victim" modus for ACLU-molded lawyers to confuse low IQ juries. ... What next - a similar program at airports to affirm that Muslims, who comprise nearly 100% of the terrorist population, are not searched in numbers greater than the percentage they represent of the flying population? And that's exactly why this bill, which has been terminally ill for over 4 years, must be killed once and for all, along with those it would ultimately help to destroy us.”
